

RESOLUTION NO: 6243
(CITY COUNCIL SERIES)

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANTA MONICA RECITING THE FACT OF THE ELECTION HELD IN SAID CITY OF SANTA MONICA ON THE 14TH DAY OF APRIL, 1981, AND ADOPTING THE STATEMENT OF RESULT OF VOTES CAST.

WHEREAS, a general municipal election was held and conducted in the City of Santa Monica, the Santa Monica-Malibu Unified School District and Santa Monica Community College District in Los Angeles County, State of California, on Tuesday, the 14th day of April, 1981, as required by law;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SANTA MONICA DOES RESOLVE AS FOLLOWS:

SECTION 1. That there were 65 consolidated voting precincts and that the total number of ballots cast was 28548

SECTION 2. That the following persons were elected members of the City Council for four-year terms:

KEN EDWARDS, DOLORES M. PRESS, DENNIS ZANE, and JAMES P. CONN.

SECTION 3. That the following person was elected member of the Rent Control Board for a four-year term:

LESLIE LAMBERT.

SECTION 4. That the following persons were elected members of the Board of Education and Governing Board of the Community College District for four-year terms:

CONNIE J. JENKINS, MARY KAY KAMATH, ILONA JO KATZ.

SECTION 5. That Proposition A, relating to Police and Protective Services was adopted.

That Proposition B, relating to Crime Control failed to be adopted.

SECTION 6. That the following statement of the results of votes cast is to be entered into the minutes of the City Council

meeting at which it is accepted by adoption of this resolution:

STATEMENT OF THE CITY CLERK

I, Ann M. Shore, City Clerk of the City of Santa Monica hereby certify the following:

That at the General Municipal Election held April 14, 1981 as provided for by the Charter of the City of Santa Monica and the Elections Code of the State of California, there were 54 consolidated voting precincts established within the boundaries of the City of Santa Monica and eleven consolidated election precincts established within the Santa Monica-Malibu Unified School District and the Santa Monica Community College District, but outside the City of Santa Monica, for a total of 65 voting precincts. That the absent voter ballots were canvassed by a board appointed by the City Clerk as provided for in the State of California Elections Code, and the official canvass was commenced by the City Clerk on April 14, 1981 and completed on April 21, 1981.

That the voting was done by Votomatic Machine Equipment in accordance with the provisions of the State of California Elections Code. That there were 25,670 ballots cast within the City, 730 ballots cast outside the City all within the Santa Monica-Malibu School District and the Santa Monica Community College District, and 2,144 absent voter ballots cast within the entire election jurisdiction for a total of 28,544 ballots cast.

That the following were candidates for the various offices:

That the following measures were voted upon:

PROPOSITION "A": Shall the City Charter be amended to add Article XIX, relating to Police and Protective Services, providing for an increase of the City's spending limit of approximately \$3,000,000 for each of the next four years and requiring the adoption of a crime prevention program?

PROPOSITION "B": Shall the City Charter be amended to add Article XIX, relating to Crime Control, providing for an increase of the City's spending limit of approximately \$3,000,000 for each of the next four years and a reduction of the City property tax by 2¢ for each \$100 of assessed valuation?

That Proposition A was adopted; Proposition B failed to be adopted.

That the following persons were elected to the office of Member of the City Council (full term):

KEN EDWARDS, DOLORES M. PRESS, DENNIS ZANE, JAMES P. CONN.

That the following named person was elected to the office of Member of the Rent Control Board (full term):

LESLIE LAMBERT.

That the following named persons were elected to the office of Member of the Board of Education and Governing Board of the Community College District (full term):

CONNIE J. JENKINS, MARY KAY KAMATH, ILONA JO KATZ.

That the number of votes in each precinct for each candidate and for and against each measure are attached as exhibit "A".

SECTION 7. That the City Clerk shall immediately make and deliver to each of such persons so elected a Certificate of Election signed by the City Clerk and duly authenticated, that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the State Constitution of the State of California and shall have them subscribe thereto and file the same in the office of the City Clerk. Whereupon, each and all of said persons so elected shall be inducted into the respective office to which they have been elected.

SECTION 8. That the City Clerk shall certify to the adoption of this Resolution.
