

RESOLUTION NO. 7251 (CCS)

(City Council Series)

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANTA MONICA APPROVING AND ADOPTING THE CERTIFICATION OF ELECTION RETURNS FOR PROPOSITION M IN SPECIAL MUNICIPAL ELECTION HELD IN CITY OF SANTA MONICA AND CONSOLIDATED WITH THE STATEWIDE PRIMARY ELECTION HELD JUNE 3, 1986.

WHEREAS, Proposition M was submitted to the voters of the City of Santa Monica at the Statewide Primary Election held Tuesday, June 3, 1986, conducted by Los Angeles County; and

WHEREAS, the total number of votes cast for and against said proposition have been calculated and certified by Charles Weissburd, Registrar-Recorder of the County of Los Angeles,

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SANTA MONICA RESOLVES AS FOLLOWS:

SECTION 1. The vote total, as certified to by Charles Weissburd, Registrar-Recorder of the County of Los Angeles, shall be and is hereby approved and adopted as the formal vote count of the City of Santa Monica regarding Proposition M.

SECTION 2. The following measure was voted upon:


PROPOSITION M. Shall Article XVIII of the City Charter, entitled "Rent Control," be amended by adding certain new sections and amending certain existing sections to provide that upon voluntary vacancy of a controlled rental unit the landlord may establish a new base rent for such controlled rental unit if the landlord complies with the provision of a program entitled "Tenant Incentive Program"?

SECTION 3. As a result of the election, a majority of voters voting on Proposition M did not vote in favor of it. The Proposition was not carried and shall not be deemed adopted and ratified. The attached Exhibit A certifies that 27,284 total ballots were cast in the City during the election; 17,202 votes were cast against Proposition M and 7,542 votes were cast for Proposition M. Attachment Exhibit B reports the number of votes at each precinct.

SECTION 4. The City Clerk shall enter above particulars on the records of the City Council of the City of Santa Monica.

SECTION 5. The City Clerk shall certify to the adoption of this Resolution, and thenceforth and thereafter the same shall be in full force and effect.
