

RESOLUTION NO. 6669(CCS)

(CITY COUNCIL SERIES)

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANTA MONICA RECITING THE FACT OF THE ELECTION HELD IN SAID CITY OF SANTA MONICA ON THE 12TH DAY OF APRIL, 1983, AND ADOPTING THE STATEMENT OF RESULT OF VOTES CAST.

WHEREAS, a general municipal election was held and conducted in the City of Santa Monica and the Santa Monica-Malibu Unified School District in Los Angeles County, State of California, on Tuesday, the 12th day of April, 1983, as required by law;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SANTA MONICA DOES RESOLVE AS FOLLOWS:

SECTION 1. That there were 65 consolidated voting precincts and that the total number of ballots cast was 29,597.

SECTION 2. That the following persons were elected members of the City Council for four-year terms:

DAVID G. EPSTEIN, WILLIAM H. JENNINGS and CHRISTINE EMERSON REED.

SECTION 3. That the following persons were elected members of the Rent Control Board for four year terms:

SUSAN PACKER DAVIS, DAVID B. FINKEL and WAYNE BAUER.

SECTION 4. That the following persons were elected members of the Board of Education for four year terms:

DELLA BARRETT, ROBERT HOLBROOK, DIANNE BERMAN and RICHARD C. WILLIAMS.

SECTION 5. That Proposition A, relating to Tenant Ownership Rights, failed to be adopted.

SECTION 6. That the following statement of the results of votes cast is to be entered into the minutes of the City Council meeting at which it is accepted by adoption of this resolution:

STATEMENT OF THE CITY CLERK

I, Joann Jelly, City Clerk of the City of Santa Monica hereby certify the following:

That at the General Municipal Election held April 12, 1983 as provided for by the Charter of the City of Santa Monica and the Elections Code of the State of California, there were 54 consolidated voting precincts established within the

boundaries of the City of Santa Monica and eleven consolidated election precincts established within the Santa Monica-Malibu Unified School District, but outside the City of Santa Monica, for a total of 65 voting precincts. That the absent voter ballots were canvassed by a board appointed by the City Clerk as provided for in the State of California Elections Code, and the official canvass was commenced by the City Clerk on April 16, 1981 and completed on April 19, 1983.

That the voting was done by Votomatic Machine Equipment in accordance with the provisions of the State of California Elections Code. That there were 29,597 ballots cast including 2,478 absent voter ballots.

That the following were candidates for the various offices:

MEMBER OF THE BOARD OF EDUCATION (full term - four years)

MEL CHALOUPKA, DELLA BARRETT, ROBERT HOLBROOK, MARILYN J. LUMSDON, DONALD K. SUJISHI, CHARLES E. KENOYER, HARRISON W. SOMMER, WERNER H. SCHENK, DIANNE BERMAN, GLORIA DENECOCHA, DOUG SCOTT, DORIS M. GANGA and RICHARD C. WILLIAMS.

That the following measure was voted upon:

PROPOSITION "A": Shall the City Charter be amended to add a new Article 19 entitled "Tenant Ownership Rights" establishing standards for the processing and approval of landlord-tenant applications for conversion of rental units to condominiums, stock cooperatives, community apartments and other forms of ownership?

That Proposition A failed to be adopted.

That the following persons were elected to the office of Member of the City Council (full term):

DAVID G. EPSTEIN, WILLIAM H. JENNINGS and CHRISTINE EMERSON REED.

That the following named persons were elected to the office of Member of the Rent Control Board (full term):

SUSAN PACKER DAVIS, DAVID B. FINKEL and WAYNE BAUER.

That the following named persons were elected to the office of Member of the Board of Education (full term):


DELLA BARRETT, ROBERT HOLBROOK, DIANNE BERMAN and RICHARD C. WILLIAMS.

That the number of votes in each precinct for each candidate and for and against each measure are attached as exhibit "A".

SECTION 7. That the City Clerk shall immediately make and deliver to each of such persons so elected a Certificate of Election signed by the City Clerk and duly authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the State Constitution of the State of California and shall have them subscribe thereto and file the same in the office of the City Clerk. Whereupon, each and all of said persons so elected shall be inducted into the respective office to which they have been elected.

SECTION 8. That the City Clerk shall certify to the adoption of this Resolution and thenceforth and thereafter the same shall be in full force and effect.
